the United States, usually within 6 months. But if it's not done right, it can be delayed for years. The requirements are that the United States petitioner and fiancé/e have actually met within the past 2 years, that they both have the capacity to marry, an absence of certain criminal convictions and the bona fide intention to marry within 90 days. The legal requirements appear simple enough, but because of the high incidents of fraud, K-1 visas are closely scrutinized at two different levels. First, at the United States Citizenship & Immigration Services (USCIS), and secondly at the US Embassy where the K Visa will be issued.

criminal convictions, issues that may arise during medical examination, insufficient proof of the relationship, and most commonly, a failure to properly document the application both at the USCIS level and the US embassy.
